# **Governance Pitfalls: Three Common Traps for Association Boards**

Governance in community associations is complex, with many potential blind spots that can lead to serious financial, legal, and operational challenges. Some of the most common yet often overlooked governance pitfalls include understanding roles, respecting the hierarchy of the documents, and failing to adhere to communication and meeting protocols.

#### **Understand Roles**

Clearly defined roles foster efficiency, minimize understandings, and prevent unnecessary overreach. The roles are:

- Board members: Act as the governing body and make decisions on behalf of the association.
- Officers: The president, treasurer, and secretary may have additional duties, but they are not necessarily board members.
- Committees: Provide support, execute assigned tasks, and follow board directives.
- Community manager: Hired by the board and acting on behalf of the association, the manager's duties are established by the management agreement. The manager almost always reports to the board, not the association's members. Some smaller communities elect not to hire a community manager.

# Facts Over Headlines: CAI Responds to Calls to Ban Florida HOAs

Community associations create stable, well-managed neighborhoods where families invest, connect, and thrive. A Florida legislator's recent call to ban homeowners associations is, respectfully, a solution in search of a problem and would cause

needless disruption for millions of Floridians. Florida thrives because neighbors choose to work together.

This week, I've given a half-dozen interviews with media across the Sunshine State to keep the conversation grounded in facts. I've shared findings from the Foundation for Community Association Research's <u>Homeowner Satisfaction Survey</u>, which consistently shows the overwhelming majority of residents living in association-governed communities are <u>satisfied with their experience</u>. The data reflects what we see every day in well-run communities that protect property values, maintain critical infrastructure, and foster a sense of harmony.

Florida law empowers homeowners with choices. If a community determines an association no longer fits its needs, Chapter 720 of the Florida statutes provides a legal pathway to dissolution through a community vote and due process. Homeowners decide the community's future.
